THIS IS A RELEASE OF LIABILITY AND A WAIVER OF YOUR RIGHTS

In consideration of my participation in any workshops facilitated by Events Wild, and for participation in all of the related activities for this program, I agree to the terms and conditions of this agreement. I understand that outdoor programs can include potentially dangerous activities. I accept and clearly understand that there are inherent dangers and other risks involved in these activities and trips, including the risk of personal injuries, and with careless conduct, even death. (please initial)

I understand the hazards of these activities (including actions taken in connection with initiating or completing them, for example, hiking in treacherous conditions, traveling to remote destinations include, by way of example and not limitation, the following: falling because of improper activity, deviation from the workshop's rules, improper preparation, injury due to faulty equipment, weather or other environmental conditions; and being injured by another participant. I agree that I alone am responsible for deciding whether to participate in these inherently risky activities and associated trips. (please initial)

I understand that there are more hazards than are enumerated here, and that there are unknown and unforeseeable hazards. (please initial)

I understand that treatment may not be immediately available if I hurt myself in an outdoor setting. (please initial)

I agree to participate in these activities at my own risk. (please initial)

I understand that participating in these workshops subjects me to foreseeable and unforeseeable hazards other than those connected with this activity, and I intend for this release to cover those hazards and all injuries resulting from those hazards. (please initial)

I therefore, for myself, my heirs, successors, representatives, and anyone else who might have a claim by reason of my injury or death, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE FROM LIABILITY, and AGREE TO INDEMNIFY, HOLD HARMLESS, and DEFEND Events Wild, its directors, officers, agents, volunteers, sponsors and their estates, from any and all liability for any and all such damage, injury, paralysis, or death to myself or any other person or to property. I explicitly agree that this release and indemnification extends to harm resulting from any NEGLIGENCE of the parties released or any party released. (please initial)

I am accepting for myself the full responsibility for any and all such damage, injury, paralysis, or death of any kind which I may sustain, whether such damage, injury, paralysis or death results from the NEGLIGENCE of Events Wild, its directors, officers, agents, volunteers, hosts, sponsors or their estates, or from some other cause. I further agree, for myself, my successors, heirs, and family not to sue Events Wild, its directors, officers, agents, volunteers, hosts, sponsors or their estates, on account of any injuries I incur in connection with participating in any activity with Events Wild, or in connection with any activities occurring on the property where the activity takes place. (please initial)

If I violate the terms of this contract and sue any party released, that party shall be entitled to recover his/her or its expenses, including attorneys' fees from me. (please initial)

I UNDERSTAND THE RISKS OF PARTICIPATING IN ACTIVITIES WITH EVENTS WILD AND I HAVE CAREFULLY READ, UNDERSTAND AND VOLUNTARILY ACCEPT THE TERMS OF THIS WAIVER AND RELEASE AGREEMENT. (please initial)

This contract is severable; that is, if any part of it is held by a court of law to be unenforceable, the rest of it shall nevertheless be effective.
